	In general, alcohol ethoxylates (AE) are readily absorbed through the skin of guinea pigs and rats and through the gastrointestinal mucosa of rats. For high boiling ethylene glycol ethers (typically triethylene- and tetraethylene glycol ethers): Skin absorption: Available skin absorption data for triethylene glycol ether (TGBE), triethylene glycol methyl ether (TGME), and triethylene glycol ethylene ether (TGEE) suggest that the rate of absorption in skin of these three glycol ethers is 22 to 34 micrograms/cm ² /hr, with the methyl ether having the highest permeation constant and the butyl ether having the lowest.
